Regional HSJCC Update	<ul> <li>Regional and Local meetings are all taking place in September Midland local: Sept 15th Collingwood local: Sept 21st Barrie local: Sept 25<sup>th</sup> Orillia local: Sept 18<sup>th</sup> Simcoe-Muskoka (Regional): Sept 18<sup>th</sup>  Janine Jones of CMHA Muskoka (also sits on this HSJCC Regional committee) inquired at our last meeting regarding starting up an HSJCC Muskoka local group. HSJCC Regional Simcoe-Muskoka committee co-chair, Judy Alton did a recent presentation at the LHIN, requesting an additional \$2,500, but was informed that no funds are available at this time. Upon further discussion; we will consider covering some meal costs from the current regional budget. Those who are interested in getting this Muskoka local area group going will be responsible to recruit members &amp; appoint a chair person for their mtgs.</li> <li>There is approx \$2,800 budgeted this year for local projects</li> <li>Judy Alton is retiring in December, so the regional group was seeking a new co-chair. Round Table	<u>OPP – Leslie Raymond</u> . The next CIT will take place the first week in	
Updates	October. There are 20 participants. Leslie is not sure what will happen after that, but expects the current format to remain until something else is developed. There is discussion about shortening the course (currently 3 days difficult) or having an on-line version.  OPP – Judy Alton. Judy's replacement could not attend today's meeting, as she is at a conference. Judy hopes she will be available for the next meeting. Judy has a replacement for the Provincial Committee as well. At our last meeting, Janine enquired about having a 5 <sup>th</sup> local in Muskoka. Judy presented this to the LHIN and requested funding for another local. The LHIN did not have a budget to support the local this year, but would possibly have funds for the next fiscal year. The local could start establishing itself in the meantime and other groups could save some money from their budgets to help them start up.  DSO - Mallory Holmes. Mallory recently did a presentation to the Collingwood Local to provide education and help dispel myths about services. She is hoping to do presentations to more HSJCC locals.	<b>Action:</b> Mallory will present to
	Barrie Police – Tom Sinclair. He indicated that he is not sure of the future of the COAST program. They have a funding application to have this continue permanently and are looking for 2 positions. The ride alongs continue at this time. Their Wellness Coordinator is on maternity leave and the replacement does not have the same background. It is expected that it will take this person some time to get up to speed on the role. The Canadian Critical Incident Stress	the Regional committee at our next Nov 27 mtg.

Foundation is providing a 3-day peer support training Nov. 27, 28, 29 with the South Simcoe Police.

<u>Catulpa – Christina Terry</u>. She is presenting at the CIT training regarding crisis response and what their program is, DS services and how to access. She is noticing developmental behavior and misunderstandings as a trend in the community. Christina is replacing Nicole Hamilton for the next 6 months.

<u>Waypoint – Terri Newman</u>. Experienced a number of aggressive incidents in August. All were unrelated. Two staff lost time from work due to their injuries. The MOL was in to investigate. In all incidents, staff were following procedures. Waypoint continues to move forward with Naloxone initiative.

<u>CMHA – Jean-Marc Pelot</u>. Experiencing a lot of staff changes in the HSJS program due to maternity leaves. Michael Dunn has accepted a permanent position with CMHA Ontario and will no longer be returning. The Research, Evaluation, Quality Improvement (REQI) Director position has been publicly posted by CMHA office in Barrie.

John Howard Society – Keith Kacsuta. They had a successful Prisoners Justice Day with a great speaker. It raised awareness and advocacy. They are starting a Youth Mental Health Walk-In Program in Orillia and Barrie for youth ages 12 – 24 years. Both programs will be on Mondays and Tuesdays from 1 – 7; the Orillia program will have an additional time of Saturdays from 11 – 2. They are also applying for a grant for a permanent Crisis Service Worker in Orillia and waiting to hear about funding for a Housing First Justice Worker, also in Orillia. Their new satellite office is at 80 Bradford St. Barrie.

**CNCC – Mary Martin.** Staffing changes continue. Hiring a social worker, addiction counsellor and nursing positions. They had a psychologist start last week. They have received increased funds for a psychiatrist to cover 3 hours/week for video OTN. They are also hoping for an announcement from Enaahtig for a Release from Custody worker.
