<i>Review and Approval of Minutes October 2, 2014</i>	<ul style="list-style-type: none"> • Approved no changes
<p><i>Provincial Updates</i></p> <ul style="list-style-type: none"> • 2015 Conference dates have been formalized and sent out for November 2015. They are lining up Key note speakers now as soon as there is more information that will be sent out to everyone. • Sandy Leath from CMHA in St. Sault Marie had been the co-chair for the past two years has stepped down. Mike Dunn from CMHA Simcoe is new co-chair along with Katie Almond from MCSCS. • Youth Justice and Mental Health – regarding a youth that went through the system and at 18 and was on house arrest and committed suicide. His mother was present as well clinical director from CMHA Wellington, Waterloo, Dufferin and a gentleman from Lutherwood. The highlight was around the gaps in the system. There were a number of recommendations within that paper that was sent forward to the Provincial HSJCC as well as a lot of dialogue around that particular situation and some of the steps to integrate the systems in a more meaningful way for youth and transitional age youth. There still seems to be significant gap between the two systems in terms of transitional age youth and who are providing service within the community in different areas. There were a lot of questions regard the psychiatric involvement and what the psychiatrist do within the court system is it a fitness assessment or a general psychiatric assessment and there seems to be differences depending on who the actual psychiatrist is on what service delivery is output . There were questions around in everybody’s community what are psychiatrist doing right now in their communities? There seems to be a lack of psychiatric or mental health supports for the more criminalized individuals. • After discussion regarding how do we make sure that we are utilizing everything where it is appropriate and how do we hold people accountable. It was suggested that perhaps setting up a smaller meeting and put together and proposal would be beneficial. H. Lumley, Heather DeBryun and Mike McMahon to check with his co-worker to see if she would be interested in sitting at this table. M. McMahon said that he had talked to C. Anderson about this and they have come up with an agreement with physicians that are based at the hospital and basically the agreement stipulates that they will not be called to testify and on that basis they were able to deal with their issue of not being able to serve justice clients because that was the main concern of the doctors. Once that was set aside the service came back. H. We need a comprehensive package in order to convince psychiatry to come on board.</p> <ul style="list-style-type: none"> • Communication and Knowledge Exchange Committee – They are planning more webinars moving forward. They are looking for local and regional members for the Knowledge Exchange Committee anyone interested in being on the committee please email H. Lumley @ hlumley@slcs.ca and she will connect them to the chair of that group. • Provincial HSJCC – Adult Therapeutic Court They have put together a working group for a review of ATC. There are a number of individuals across the province. From our area H. Lumley offered Michele Murray-Smith from SLCS as she is knowledgeable about St. Thomas as well as some information for Oxford and because she had three different lenses on the courts that she could represent the South West on the working group. They are looking for people from all aspects of care. CMHA Ontario is chairing that. • Federal Corrections discussion – Mental Health strategy for corrections has not moved forward in the fashion that they had suggested it was going to a few years ago. So what we see with the feds is that they are cutting most of the community corrections services. That poses a very significant issue for all of our communities because people are staying in prison longer and when they come out they are less connected and have less skills at reintegrating into the community in a prosocial and meaningful way. Going to be a very large problem very soon in everyone’s backyard. If anyone has any thoughts on how to integrate federal corrections people as they don’t understand mental health as mental health providers understand mental health. The issue with the risk management is significant so there is a big gap for those individuals coming back. 	<ul style="list-style-type: none"> • H. Lumley to look for quote and bring to first meeting

We have different local agency’s host it at the court house • Started some of the Crisis Intervention Training Modules with Judy’s group • Looking to start our Mental Health Court in January. • Oxford – <ul style="list-style-type: none"> • On the basis of the Crisis Intervention training that has been provided over the past 2 1/2 years the OPP have launched a mental health team called the Crisis Intervention Team for Oxford OPP. Launching in the 	

<p>winter/spring.</p> <ul style="list-style-type: none"> • Mental Health Court continues. Will have their first self-evaluation lead by the administrative justice on December 11/14 but has been operating since June. • Oxford Connex table meeting once weekly for individuals at acute risk in the community. In the afternoon of the meeting the Intervention Team are making contact with the individuals that are brought to the table. The police are most often bringing the cases to the table and have seen four cases in three weeks. This is just starting here on a six month pilot. • Windsor – <ul style="list-style-type: none"> • The court is working well. We have a lunch and learn planned for February where we are bringing in all the different sectors into the court house to talk about mental health court and what it can and can't do. • Lambton – <ul style="list-style-type: none"> • Local meetings are taking an educational turn and having expertise from table presenting at meetings • CIT coming up with one in Chatham and one in Lambton • FASD training scheduled for November has had to postpone until the spring. If the training happens before March 31/14 that is fine. If this can't be used in this fiscal year we need to know so that somebody else can use this money. • OPP – <ul style="list-style-type: none"> • Trainings next week in Sarnia. • In the last three courses we invited 2 Probation & Parole officers to attend and it has been well received. Will probably continue to invite a couple more for the next few sessions as well. • OPP working on a Provincial Mental Health strategy right now and is supposed to be completed at the end of March. Once they receive the final paper on that Judy will share it with the committee • Southern Network – <ul style="list-style-type: none"> • Their provincial body was approached by MCSS to develop a training package for police across the province. Includes developing training vignettes and course materials. In the process of writing up the proposal for the ministry. Part of the package is the Special Needs Offender Manual that will be part of the package moving forward. This will take 1 – 1 ½ years to put together. It is to help officers deal with individuals that have a developmental disability • Sent out their newsletter • Working in Brantford on Justice and Dual Diagnosis project with the police and a professor from Laurier University at the Brantford campus. • Liz is having a difficult time attending a lot of meetings and would like to have Cindy Chatzis the Healthcare Facilitator with Southern Network attend these meetings when Liz is not able to. Cindy is a registered nurse and has worked on the forensic unit at St. Joe's in Hamilton and has mental health and developmental services experience. Agreed to have Cindy Chatzis attend when Liz is unable. • Liz will talk to Cindy about taking on the funding committee portion as well and get back to H. Lumley

CMHA, Addiction Service and any other provider that necessary to provide care for the individuals. Running into roadblock with getting a psychiatrist and medications for some of the people. One of the things that we found extremely helpful where the people that were notorious for falling through the cracks what we have learned is that sometimes when they are coming back to our communities they go to several jails before the actually get back to London and we were losing them in the system. That situation has been resolved when we have probation at the table who can track them and provide the information on the arrival and letting us connect with the people.
