	THE FAM NETWORK INC., a not-for-profit corporation duly incorporated under the Laws of Canada
	(hereinafter referred to as "The FAM Network") OF THE FIRST PART;
AND:	(full name of Pet Owner), an individual residing in Ottawa, in the Province of Ontario
	(hereinafter referred to as "Pet Owner") OF THE SECOND PART.

WHEREAS The FAM Network provides temporary care, through it's the FAM Network Placement Program, to pets of individuals who are receiving in-patient treatment for substance abuse;

AND WHEREAS the Pet Owner wishes to participate in the The FAM Network Placement Program, such that The FAM Network will temporarily take the Pet Owner's animal(s) (the "Foster Animal(s)"), as described below, into care in order to be placed with a pet foster parent until such time as the Pet Owner is no longer receiving in-patient treatment for substance abuse;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT, in consideration of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. The preamble will form an integral part of this Agreement.
- 2. The FAM Network agrees to provide the Foster Animal(s) described below, free of charge, all veterinary services deemed necessary for placement of the Foster Animal(s) with a pet foster parent. The FAM Network will be giving custody of the Foster Animal(s) to such pet foster parent who will

enter into an appropriate agreement with The FAM Network prior to taking custody of the Foster Animal(s).

- 3. The FAM Network retains the right to refuse to accept, or refuse to place with a pet foster parent, any Foster Animal(s) that, at the sole discretion of The FAM Network or their agent, is deemed to endanger the health of other animals and/or the safety of staff, volunteers, or the pet foster parent and their family.
- 4. The Pet Owner hereby certifies that they are the owner of the Foster Animal(s) described below, and agrees to allow The FAM Network to provide any necessary veterinary care, including diagnostic, therapeutic, surgical, preventative treatment and euthanasia as may be deemed appropriate by The FAM Network, at their sole discretion, during the term of the agreement. Where possible, The FAM Network will endeavor to obtain prior approval from the Pet Owner for such treatments, but approval from the Pet Owner will not be required in order for The FAM Network to proceed with treatment, at its own expense.
- 5. The Pet Owner hereby releases The FAM Network and its affiliates and their respective officers, directors, employees, and agents, as well as all pet foster parents, from any liability by reason of loss or injury relating to the Foster Animal(s) which may derive from any cause whatever, including the rendering or failure to render veterinary care, or relating to the placement of the Foster Animal(s) with a pet foster parent.
- 6. In the event that the Pet Owner wishes to terminate this Agreement and retrieve the Foster Animal(s) described below, they must provide The FAM Network with no less than forty-eight (48) hours' notice.

- 8. This agreement shall terminate when the Pet Owner ceases to receive in-patient treatment for substance abuse. At that time, the Pet Owner shall be required to notify The FAM Network, and the Pet Owner shall be required to retrieve the Foster Animal(s) within forty-eight (48) hours.
- 9. In the event that the Pet Owner fails to retrieve the Foster Animal(s) within forty-eight (48) hours of the termination of this Agreement, The FAM Network reserves the right to transfer the Foster Animal(s) to such organizations, at The FAM Network's discretion, as will be responsible for rehoming the Foster Animal(s).
- 10. The Pet Owner agrees that the existence of this agreement, the terms of this agreement, and all information provided to them by The FAM Network, including but not limited to the location of the Foster Animal(s), or any information pertaining to the pet foster parents, shall remain confidential and the Pet Owner will not disclose any such information to any other person. The Pet Owner acknowledges and agrees that a breach of this section would cause irreparable harm and injury to The FAM Network, its employees, volunteers, and pet foster parents, including but not limited to direct physical harm. This term shall survive the termination of this agreement indefinitely.
- 11. This Agreement shall be governed by and construed under the laws of the Province of Ontario.
- 12. This Agreement represents the entire understanding of the parties and no modifications thereof, nor additions thereto, will be binding unless in writing, having direct reference to this Agreement and executed by all parties.
- 13. This Agreement shall ensure to the benefit of and be binding upon the parties hereto, their respective successors and assigns.
