#### **1.** Welcome and Introductions

• Everyone introduced themselves.

#### **2.** Adoption of the Agenda

• The Agenda was approved with the following change: Item 3 - We do not have to make a decision on the Justice Collaborative.

#### **3.** Review the Minutes of October 4, 2012 and January 30, 2013

• The minutes of both meetings were approved.

#### 4. Justice Collaborative - Overview provided by Sajedeh Zahraei.

- There are 18 service collaboratives. Four will be Justice Collaboratives. Toronto and Champlain have been chosen so far as two areas to start the Justice Collaborative. Toronto will focus on adults.
- The Justice Collaborative is part of the Ministry's ten-year mental health and addictions strategy.
- The Ministry has identified Toronto and Champlain as the two areas that will address adult and justice.

- The January 30<sup>th</sup> T-HSJCC meeting was the starting point. Main focus to date has been community engagement to look at the gaps and barriers, and then identify what the building blocks to address them.
- Sajedeh Zahraei has met with all the Toronto HSJCC locals and the Complex Committee.
- Based on the community engagement thus far, a needs and gaps information sheet was distributed. The CAMH PSSP "Community Engagement Strategy for the Toronto Justice Service Collaborative" was distributed.
- The next stage in the process is to look at the HSJCC membership to address stakeholders that are missing from the membership.
- On April 10, 2013 a Town Hall meeting is scheduled. All T-HSJCC members are invited, including new stakeholders.

# Broader perspective

- Needs validation process
  - What are the needs of the clients? A report will be completed at the end of the first phase looking at the needs, gaps and resources. The report will be disseminated at the end of May 2013.
  - Key questions: What did people see as the gaps in membership? Who should we engage with?

# The following issues were identified:

- People being stuck in the system and released with no support. Support happens ad hoc.
- Gap in gender-informed/responsive service was discussed.
- Trauma informed services are lacking.
- Toronto collaborative has many challenges and issues.
- How much focus from the adult justice collaborative will be local?
- There have always been gaps and needs. Should address what has worked with what has been done so far. Concerns expressed with revisiting the needs and gaps.
- Suggestion was made to do an evaluation at the local level. What can we learn about the local? What has worked in the justice network and what is the capacity? Catalogue the process, improvement and gaps.
- The collaborative project will have an 18-month implementation process
- Aboriginal courts are in parallel with other courts. Sajedeh Zahraei met with the Aboriginal Legal Service addressed that their clients do not use court diversion or other services. They are interested in accessing court diversion.
- Other groups to connect with were suggested Women's Mental Health and Addiction Group, The Dream Team, Advocacy Resource Centre, Child Welfare, FASD.
- Immigration issues were identified as an area to address.
- The intension of the Service Collaborative is to see best practice being applied to the system.

- It was suggested that staff at the justice sector could be interviewed to see what is missing at the junctures points where justice and health meet. Need to look at the juncture point not the transitional point. i.e., courts and police. What can we do to prevent police intervention?
- Conversation and data validation process go hand in hand

Discussion points re decision -making and next steps:

- The April 10<sup>th</sup> Town Hall meeting will be an information session for discussing the process.
- Following the April 10<sup>th</sup> meeting, interested parties will be asked to meet again to refine/ develop options for the justice collaborative. Results will be reported to HSJCC and there will be a link as the collaborative develops.

- S-HSJCC had a successful symposium on Emerging Issues In Our Aging Population with guest speaker Patricia Fleishmann.
