## **Land Acknowledgement**

Susan Davis noted the Land Acknowledgement statement.

### **Welcome and Introductions**

Everyone introduced themselves.

**Presentation:** Justice Centre and the Youth Justice Centre with Kate Mathews, MAG Lead, Justice Mary Hogan, Miriam Henry, MAG and Scott McKean from the City of Toronto

- PowerPoint presentaion slides deck will be circulated.
- Background information was provided.
- The model draws from innovative practices around the world. Community needs
  assessment was conducted resulting in shared provincial vision with integrated service
  delivery as well as four local adaptations.
- Current context: Ontario is introducing four unique J ustice Centres models through initial Pilots to be evaluated in advance of expansion.
- Following the onset of COVID-19, MAG-CLD worked with community and justice
  participants to identify how Pilots could be adapted to promote access to justice and
  address the accumulation cases in the OCJ. Key adaptations are:

o Including both virtual and remote court proceedings for certain matters; o Reducing the number of individuals held on bail and remand(in the appropriate cases) while

balancing need to protect public safety;

o Improving continued access to in-person, wrap-around community-based supports, with a focus on connecting people to virtual services; and

o Safeguarding access to justice for vulnerable, racialized and self-represented individuals in contact with the justice system (in collaboration with LAO and Defence Bar).

- Justice Hogan noted that she went to Red Hook Community Justice Centre in Brooklyn New York and saw the opportunity of wrap-around contributing to the social determinants of health. It was acknowledged that Justice Centre provide wrap-around services to understand and connect people to services. From the beginning the worker will be there to help them.
- The London Pilot project opened in September.
- Local Model: Hybrid Health & Justice Centre. The Toronto Downtown East (DTE) is a
  pilot for individuals with a history of recidivism. Sound Times is embedded at 51 Division
  and they have case mangers on site to meet with people to create a bail plan. Integrated
  access case managers; enhanced phychiatrist, primary care and addictions medicine;
  and digital technology to attend OCJ Justice appearances. All-in-person health and case
  management services, including video access to be located at Sound Times.
- Purpose of pre-trial to assess how they are doing with their plan. This gives the
  opportunity to address bail conditions that are challenging.
- Miriam Henry presented on the Toronto North West (TNW) Justice Centre whose focus
  is youth. Six Division are invoved. Cognizant of the ongoing gun issues, impact of trauma
  on young people and the neighbourhood has many kids.
- Do they have a lawyer? Enhanced First Appearance: Assessment can be done in-house and make referrals, including and educational plan. Using an individualized tailored to appropriate cultural services, not a traditional approach. Ensuring safe equitable access for youth.
- Scott McKean presented on Safe TO/Community Safety and Wellbeing Plan. It aims to inspire a culture of prevention and collaboration to help bring about a safer Toronto
- To achieve this, the City will leverage its role as a service provider, policy developer, partner, system navigator, convenor and negotiator.

**Themes discussed:** The presenters were thanked for their work and sharing the information. It was noted that the work they are doing will benefit individuals going through the justice system specifically the wrap-around service.

- Toronto East has an older population, thus building trust is the main issue and is essential to meet people where they are at.
- Tricia noted that the services do not state cognitive impairment, brain injury and developmental disability.
- Scott informed the committee that ABI and development disability have been recognized and are included in the Safe TO Plan.

- Appreciation for the work of the Safe TO Plan for recognizing brain injury, development disability was given.
- Samim inquired whether there has been a Justice Centre needs assessment in Scarborough? Scott stated that there are discussions going on about Scarboorugh.
- It was noted that neurodisability has been added to the HSJCC workplans.

## Addressing Anti-Racism Across the HSJCC Network Regional and Local HSJCC Survey

#### **West Toronto HSJCC:**

Patricia provided a report.

• At the May meeting there was a presentation with Jin Chien staff lawyer at the Chinese & Southeast Asian Clinic. Acknowledging the experience of racialized groups. Access to technology has been identified as a challenge to access virtual court. The committee has agreed to purchase flip phones for clients based on available funds. The April 29<sup>th</sup> Lunch and Learn on Suicide Risk and the COVID-19 Pandemic: Transforming threat to skills for safer living 100% evaluated the session very good to excellent. Ninety-two people attended the session.

# **North York HSJCC**

Dina provided the report.

 At the May meeting Jin Chien, staff lawyer at the Chinese & Southeast Asian Clinic presented on their program and the impact of racism on their client population. There was a Lunch and Learn on March 31 on Anti-Black Racism: A Discussion with the Black Legal Action Centre (BLAC). The session was successful. At the March meeting Sue MacLennan from the Aboriginal Legal Services presented on the challenges to Gladue court during Covid-19.

# Scarborough HSJCC

Samim provided the report.

The committee met in May the Chinese & Southeast Asian Clinic presented. The
committee has incorporated the Land Acknowledgement and addressing BIPOC
community concerns. It is also working on a Scarborough Resource Directory and the
Scarborough Addiction Services Partnership has agreed to amalgamate mental health
and justice organizations to the database. The committee is monitoring engagement to
ensure that equity seeking and racialized groups and concerns are addressed.

#### **Downtown Toronto HSJCC**

Katie provided the report.

- The committee met in May and had a presentaion on the Sentencing and Parole Project (SPP). It is a non-profit organization that prepares enhanced presentence reports (EPSRs) for Black people marginalized by poverty and racial inequality.
- The reports give judges and parole boards the information they need to make informed sentencing and release decisions. They include recommendations for culturally appropriate programs to assist with rehabilitation.

**Update from the Toronto Service Resolution Project (TSRP):** Katie provided the report. The DT-HSJCC is exploring how to integrate the anti-Black racism/ Indigenous discussion with the TSRP. Discussed the context of the project as well whether or not the DT-HSJCC should become a SR table?

# **Update from the P-HSJCC**

Katie reported that the conference will be virtual in November 2021. The Specialized Courts Forum -- 500 people attend from across the country. The forum examined various models of alternative and therapeutic jurisprudence courts. Several people with lived experience attended as guests and as presenters.

The committee is exploring ways to address COVID-19 impacts and anti- black racism. A provincial Anti-Racism Committee has been established. On April 30<sup>th</sup> Tanya Sharpe presented on Homicide impact on racialized communities. It was very well attended.
