Setting the Context



Did you know?


Prior to 2003, Canada was the **leader** in the Western industrialized world for jailing youth

- The YCJA was then introduced to decrease the use of incarceration for young people
- The YCJA has been successful – **but not for all youth!**
- Existing research, though limited, highlights areas of concern

The Research


- **MAG's ICON 2006-2017**
 - **159 301** youth cases
- **MCCSS Admissions 2006-2015**
 - **64 111** detention admissions
- **Online survey: 45** stakeholders
- **Think Tank Day: 49** stakeholders
- **Interviews: 15** youth with lived experience



Key Findings




Many youth **spend days, weeks or longer incarcerated** while they wait for a decision on their bail.




Time to a Bail Decision

Although many are eventually released, a significant number of youth spend days, weeks or longer incarcerated while they wait for a decision on their bail.

Time Spent Awaiting a Decision on Bail in Ontario Youth Criminal Cases




The **time** between their first **bail** appearance in court and when their case is finally resolved is getting **longer**.




Time to a Final Disposition

Young people are waiting longer for their cases to be resolved, often resulting in further charges from breached conditions

Time Spent Awaiting a Final Disposition Date on Ontario Youth Bail Cases (2006-2018)




Regional differences suggest the YCJA may **not** be **consistently** applied across the province.




Regional Differences

Regional differences in outcomes suggest the YCJA may not be consistently applied across the province.





Number of Bail Appearances to Reach a Bail Decision in Ontario Youth Criminal Cases by Region (2006-2017)




Overrepresentation to Admissions



Black and Indigenous youth are overrepresented in admissions to pre-trial detention


Admissions to Detention for Black Youth 2006-2016

Experiences of arrest and incarceration



“People go into jail and come out worse. You gain mental health challenges because of jail. And solitary confinement? You see the walls moving because you’ve been there so long.”

Alternatives to the formal court process

“Its not like I was committing these serious crimes – it was stupid [stuff]. But they weren’t looking into why I was doing these crimes. Just, ‘here’s the punishment’ instead of ‘hey, maybe this kid’s not doing okay”

Release plans



“I was homeless, too, and I already had custody issues with my father. It was more on his end... he wasn’t allowed to parent. They thought it was cool to throw me in with my dad, so they had to figure out custody issues first. I had nowhere to go, so that was my last resort.”

Bail conditions

“They gave me so many conditions that even breathing felt like breaching. They were very hard to follow in the way that I had so many. I couldn’t go to many places; I was confined to one area – and that’s what they wanted. At the time, I thought that they wanted this and wanted to send me back.”

Regional and demographic based variations



“I remember one time I was gonna go to McDonald’s at 6am. This lady... I didn’t know her... well, apparently there was a scuffle with another group of natives.

I went to get my coffee and she stopped me. And every chance that I tried to talk to her, she’s like, ‘no, nobody wants you in there, it’s not for you’. I went in anyways and came out. She was OPP and in uniform.”

Cross-system Involvement

[In relation to groups homes]

“[it’s] like going from one system to the next, they’re just setting [us] up for failure”

- Youth

Community based services and programs to realize the potential of the YCJA





Focused strategies to **address** the **overrepresentation of Black and Indigenous youth** in detention admissions




Recommendations
