Presentation: Tammy Tinney, MSW, Mental Health and Justice Treatment and Support Services, North York General Hospital – Branson Site

- Presentation slide decks will be circulated.
- MHJTSS is a shorter-term outpatient Mental Health program located at the NYGH Branson site.
- Specialize in providing clinical support for individuals who have been charged and/or convicted of a criminal offence, and who also need MH/psychiatric assessments
- Discussed program objectives
- Have Social Worker, Occupational Therapist and Psychiatrists part of the team
- Must complete a referral form
- OHIP require
- MH concerns from service users and current involvement in the criminal justice system
- Exclusion criteria service user who has a development delay, no OHIP
- Provide biopsychosocial assessments by SW/occupational therapist

- Anger Management & Assessment Skills Building Group 8 weeks, max. 20 people per group. Service users receive a certificate at the end of the group.
- Three months waitlist to see a psychiatrist
- 1-2 month for family doctor

- Services provide for six months
- Psychiatrist will provide report for the courts
