## Review of March 5, 2019 minutes

The minutes of the March 5, 2019 meeting were approved.

#### **Review Action Items:**

Action items were reviewed and completed.

#### **Presentation:**

Robyn Keystone from Literal Change

- Literal Change was approached by the Crown Attorney's Office to provide remedial literacy support for young people who came into contact with the law.
- Provide remedial literacy at the Toronto South Detention Centre and Toronto East Detention Centre. Using one-on-one approach. They have 20 volunteers frequenting the facilities on a regular basis.
- In September 2018 they launched a youth literacy program at Jane and Finch
- Piloted project showed the need and effectiveness of the program
- Literacy program has been part of diversion for youth by removing charges
- Methodology individualized, multi-sensory approach

- Literacy program can help with educational outcomes and incarceration
- Use Orton Gillingham approach to literacy
- How are people identified- self identified at TSDC can put a request through CO. Diversion program with the courts requires 20 sessions.
- Video of their work with students was viewed
- Plan to expand in 2020
- Themes discussed: Can the program be built through probation?

Next Lunch and Learn scheduled for June 13, 2019 on Domestic Violence Charges and Programs in Ontario Wth Sarah James, Rhea Harry and Nicole McEachran from John Howard Society of Toronto.

At the end of the presentation, participants will:

- Have an increased awareness of programs serving individuals accused with Domestic Violence charges.
- Have an increased knowledge and awareness of intervention/prevention strategies for individuals with Domestic Violence charges.

#### Members Evaluation:

**Response Rate:** 70% of regular members completed the evaluation. 7 out of 10 completed the evaluation from a total of 41.

Lunch and Learn suggested topics:

- Safe beds
- Any agencies that provide addictions support in the West end
- FASD
- Sex Trade workers, how to identify those at risk and ways to help all MH disorders, treatment, services, learning disabilities, and for all of the above, communication strategies

#### **Agency/Organization Updates**

Mary Jane Ellis reported that the courthouse is addressing the need of storage space for clothing donations. She and Justice Ted Edwards are looking into storage space and will update the committee. This will help when the courthouse becomes the place that people are first released from and need cloths.
