- Reintegration Centre
 - Domenica Dileo will contact Amber Keller from the John Howard Society to arrange an update on the Reintegration Centre at the next meeting. The WT-HSJCC would like to discuss what role and/or support we can provide.
 - Domenica reported that Brad Gill Tamcsu has a scheduling conflict and is unable to attend the WT-HSJCC meeting. Brad reported that the TSDC had a public open house during the weekend. They accommodated over 3300 public visitors over a three-day period. A specific TSDC opening date and inmate transition plan have not been confirmed.
- Iustice Collaborative
 - Umwali Sollange distributed the Map of Synthesized Issues & Preliminary Priorities, which will be included with the minutes.
 - The JC has had 4 meetings since April.

- The gap they are focusing on is from Point 1 and 6 on the map initial arrest and discharge.
- - Point 1 Lack of cultural understanding, timely service, impact of stigma, how people interact with the courts, impact of racism, MH and A.
- Point 6 Release How to reduce recidivism? After someone is released do we have the support? Limited discharge planning will be suggested as a gap at the next JC meeting.
