Presentation – Tanya Connors, CAMH Forensic Early Intervention Services at the TSDC

- Presentation slide deck will be distributed with the minutes.
- A designated hospital under the Criminal Code of Canada
- 193 forensic beds
- 350 forensic outpatient clients
- FEIS is an alternative care pathway collaboration between Centre for Addiction and Mental Health, Ministry of Community Safety and Correctional Services and the Ministry of Health and Long Term Care
- The goal is to enhance timely access to acute forensic services for individuals identified with specific forensic mental health needs or at risk of falling under the mental disorder provisions as defined by the Criminal Code of Canada
- TSDC provides initial mental health (Brief Jail Mental Health Screen) screen on admission. They Identify individuals at risk and refer to FEIS when appropriate.
- FEIS completes Jail Screening Assessment Tool within 24 hours of admission

- Provides assessment and recommendations on all clients referred by TSDC staff
- FEIS collaborates with TSDC staff in the further development and refinement of these treatment plans, then remains engaged with inmates who meet inclusion criteria
- FEIS can coordinate with 102 court
- Does not prescribe meds but the Doctor makes recommendations
- FEIS is mobile within the jail, the community and the court
- Only addresses mental health issues
- Committee asked if FEIS could increase psychiatric services at the Metro West Courthouse.
- Tanya Connors said she would speak to Doctor Sandy Simpson to further understand the issues
- Tanya Connors was thanked for her informative presentation.
