### **Munch and Learns**

### Presentation - Dan Breault, SPIDER/FOCUS REXDALE

- Presentation slide deck will be distributed with the minutes.
- FOCUS REXDALE is a multi-disciplinary approach to reducing crime and improving community resilience. Address violence to others or self.
- Have a Steering Committee which conducts interventions based on acutely elevated levels of risk (AER)

- Quarterly Review for system issues
- Identify opportunity for Neighbourhood Planning Tables
- Provided definition of AER: Situations deemed, through a variety of criteria and perspectives, from a variety of agencies to meet risk intervention because of a high probability that they will become emergencies involving social disorder, crime, or victimization
- Agencies that sit at the table can refer
- S.P.I.D.E.R. Specialized Program for Enhanced Interdivisional Responsiveness to reduce recurrence of risks, and ensure safe integration and inclusion of vulnerable Torontonians in their neighbourhood. To develop coordinated responses to complex and unresolved health and safety risks that involve vulnerable individuals. It's a city wide initiative. It's a separate program from FOCUS REXDALE.
- Ensuring existing health care, social and community services are made available; and identifying and driving needed systemic reforms.
- SPIDER structure based on FOCUS REXDALE. It has Steering Committee, System Reform Table, Local or Inter-government Policy Change, Situation Table (Front Line)
- Referrals Only participating Division at the SPIDER Situation Table can refer a case
- City Division that do not participate at SIPDER may contact SPIDER for guidance
- SPIDER Program does not take referrals from the public
- Accomplishments to date were discussed. Nineteen numbered cases on file

- Dan Breault was thanked for his informative presentation.

### 2015/2016 Work Plan

- The revised work plan was distributed and approved.
- Discussion ensued on the S-HSJCC model to include people with lived experience on the committee. The S-HSJCC had a presentation from Voices from the Street who were able to refer people with lived experience to join the committee who completed their leadership training and meet the committee's criteria.
- It was decided to invite Voices from the Street to present at the next meeting. If they are available we will invite the Peer Support staff from John Howard Society of Toronto to present.
- Budget to the T-HSICC:
  - To provide TTC tokens and food vouchers support at the courthouse and the Reintegration Centre because video bail will take place at the TSDC It was identified that it is a much-needed service. It was agreed that the TTC tokens and Food Vouchers be divided between the Courthouse and the Reintegration Centre. It is recommended that

\$500 go towards tokens and \$500 towards food vouchers (\$1000 total).

- o Lunch and Learns: \$940 total for three Lunch and Learns
- o Honorarium for People with Lived Experience. \$600 total

## TOTAL BUDGET = \$2,540

# **Agency/Organization Updates**

- Leann Gallant reported on the new CMHA program Post Incarceration Housing Worker. The handout and referral form was distributed. Objective is to prevent the cycle of homelessness and incarceration by assisting individuals to find and maintain affordable housing. We also help them to obtain the services and supports they need in their community. CMHA Toronto Post Incarceration Housing Workers are available at the Etobicoke, North York and Scarborough courts to assist individuals who are released from custody or have court matters. Assist with housing and working on program criteria.
- The program is working with concurrent populations. Referral form will be included with the minutes.
- Amber Kellen reported on the Reintegration Centre. They have heat and water. Clients are beginning to come in. Completed 25 assessments. The Harm Reduction Advisory Committee is having their first meeting. A key member on the committee is Victor Wills from PARC.

### Updates from the T-HSJCC and Provincial HSJCC
