**List of Key Activities & Initiatives**

The WT-HSJCC works collaboratively:

**I.** To assist in developing and maintaining an accessible and well-functioning system of mental health, justice and related services that work together to improve the transition between services and sectors, of the Committee’s target population. This includes service provision to and through the services and supports that they need, when they need them.

**II.** To assist with improving the quality of services for individuals with mental health and substance use issues who are involved with the criminal justice system, including making specific matches between clients and services both initially and through clients’ individual recoveries over time.

**III.** To assist to minimize the amount of time people spend in correctional facilities waiting for assessments, e.g. (fitness, Form 6 and/or services they need to support their safe, successful release and re-integration back into the community).

**IV.** To assist to identify barriers to achievement of any of the above objectives, with a particular foci on identifying and addressing barriers at the interfaces between the mental health, substance use, criminal justice and related systems.

**V.** To assist in reducing recidivism.

**VI.** To improve the experience of equity seeking and racialized groups; recognize, support and engage with Black and Indigenous communities within the efforts of the West Toronto HSJCC OR in accordance with the mandate of the West Toronto HSJCC.

**VII.** To promote self-awareness/ reflection through education and dialogue about the equity impact of social determinants of health and how they may manifest in the work of the West Toronto HSJCC.
